**Small breed** pets often suffer from **retained deciduate (baby) teeth** after their adult teeth grow in. This condition creates overcrowding of teeth, retention of food or other debris between the teeth, and tarter buildup. This, in turn, leads to bad breath and damage to gums and adult teeth. We strongly recommend that these **deciduate teeth be extracted** while your pet is under anesthesia to avoid future complications. The cost for this procedure varies based the number of teeth extracted but usually ranges from \$ 12 to \$ 48

**Microchipping** pets involves inserting a tiny rice-like microchip under your pet's skin. This chip then holds your pet's identity for life. If your pet is ever lost and a local shelter or veterinary practice finds it, the law requires that all pets be scanned for a microchip before they are adopted out or euthanized.
